The total expenditure incurred towards e- governance during the year 2020-21 is **Rs 1,44,037/-**

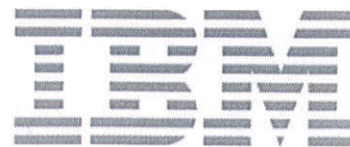

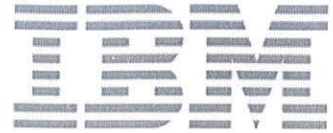
